What makes SLC the best is the beauty of the site, the richness of the people and the program, the sense of history and tradition, and the magic we create when the whole thing comes together. We are particularly proud of our open, inclusive community that is sensitive to the needs of interfaith and diverse families.

In 2016, there were over 700 individual campers served and SLC awarded over \$1,000,000 in scholarships. In addition, there were over 20 Bar/Bat Mitzvahs during camp.
